What happens when I contact the Office of the Dean of Students?



Office of the Dean of Students Services

- 1. Assess for safety on an ongoing basis
- 2. Provide services under the FERPA (Family Education Rights and Privacy Act) definition of privacy
- 3. Provide short-term case management and possibly follow-up with the goal to minimize the health concern's impact on their academics
- 4. Coordinate services from other campus or community spaces
- 5. Services are defined by student and student's context unless there is an imminent safety concern
- 6. Facilitate academic modification or assistance from professors or department in limited circumstances
- 7. Connect student to long-term campus or community healing services and reporting options

Master's Graduation Process

- Spring Statement of Completion deadline: June 25th
- Do not submit Statements of Completion until all department requirements have been met (grades are in, terminal projects approved, etc.)
- Thesis grades: after the Graduate School approves the thesis the "I" grades for 503 will be changed automatically as part of the graduation process.
 - Note: This will be changing soon!



Summer





Summer Registration

- Summer registration is required if students complete advancement requirements, major exams, graduate, or use faculty/staff resources in the summer.
- Departments shall not discourage GEs from summer enrollment.



Summer Tuition Waiver

http://gradschool.uoregon.edu/gtf/summer-sandwich

- Covers tuition for up to 16 credits used to meet degree requirements (excluding those with irregular fees).
- Students are responsible for 65% of fees

Eligibility Criteria	Action Needed
A summer term GE appointment.	No action needed. The tuition waiver will be applied with the appointment.
A GE appointment in any two quarters of the preceding academic year (that is, the preceding fall, winter, and spring).	Complete and submit the <u>Summer Tuition Waiver Request</u> by May 10 (or the closest business day) to ensure it is processed before the start of the applicable summer term. Forms will be accepted through September 10 (or the closest business day) following the applicable summer.
A fiscal year GE appointment that includes the applicable summer (that is, the dates on the Notice of Appointment are July 1-June 30 and the assignment is for research).	No action needed. The tuition waiver will be applied with the appointment.

Policy Updates

Thesis/Dissertation Grades

- Faculty will enter "P" for students making good progress
- "I" should be used like an I in any other course
- Trying for Fall 2019 effective date

Satisfactory Academic Progress

- Effective Fall 2019: Dismissal recommendations must come from Dept. Head or Dean/Dean's designee
- Full policy (probation, etc.) to be implemented by Fall 2020



Policy Updates

Graduate Course Repeat Policy

- Students can take a non-repeatable course up to 3 times
- Only the most recent attempt will count toward GPA and total credits
- Effective Fall 2020

Doctoral Residency Requirement

- Change from 3 consecutive full-time terms to 27 UO credits (i.e., could be taken on a part-time basis)
- "Soft roll-out" Fall 2019 Official effective date Fall 2020
