- First Year Fellows and Raymund Fellows are not GEs

## **First Year Fellows Reminders**

- Salary equivalent to a first year GE in the department at the appropriate level – disbursed quarterly through student billing
- Tuition and fees are covered
- UO student insurance not GTFF insurance
- No GE appointments allowed
- Raymunds: same as above, except salary

- Admission turnaround time
  - Ten business days from date department recommends for admission in GradWeb
- Admission Status:
  - Online Apps > Decisions > Admitted
    - Not Yet Processed
    - Pending List More Documentation/information Required
      - Shows the Reason
    - Graduate School Approval Provided for Decision Type: Admitted

  - Singularity Request Form (PDF)
  - Office of the Registrar, Singularity Permissions Form

- Fee Waivers
- 2019-2020 Departmental deadline considerations (no weekends/holidays)

## **Admission Offer Letters**

- 1. <u>CGS Resolution</u> required for funding offers (Monday, April 16)
- 2. All letters require statement about final UO admission
- 3. Include the following elements related to your funding offer, especially for international graduate offers of admission. By including this information, the offer letter can be used by the Office of Admission as proof of financial resources. Include:
  - A paragraph indicating the timeframe of the year a reference to the academic year is sufficient.
  - Indication of the monthly stipend and base rate.

## **Admissions Announcement**

Beginning February 6<sup>th</sup>, 2018, the Graduate School will consider three-year Bachelor's degrees from India to be equivalent to a regionally accredited four year U.S. Bachelor's degree, *without requiring an external credential evaluation*, if the degree is:

• Awarded in the First Division

#### AND

• Awarded by an NAAC Grade "A" accredited university.
